Interventions that States, Tribal Nations, and U.S. Territories Plan to Include in Their Family First Prevention and Services Act Plan (Third Edition)¹

Document Overview

As of January 6, 2023, the FFPSA Prevention Services Clearinghouse has reviewed **129** programs and services; 66 of these have been rated – with 33 rated as *promising*, 16 as *supported*, or 17 as *well-supported*.² This document provides information about three areas:

- (1) What interventions have been rated by the FFPSA Prevention Clearinghouse (Table 1) or approved through the ACF Technical Review process (Table 2).
- (2) Interventions that were reviewed by the Prevention Clearinghouse but had insufficient evidence for review. (See Appendix A for that information and the <u>Clearinghouse</u> website for which interventions are currently under review or planned for review.)
- (3) The interventions that states plan to include in their FFPSA plan or have included in their plan that has been approved for use by the Federal Government. (See Table 3.)




Figure 1. Status of Family First Prevention Plans as of December 22, 2022

Note that this is a very dynamic situation, and states may update their intervention choices at any time and seek Federal approval for that change. We will publish updates of this summary about twice per year to keep this as accurate as possible. For example, Washington DC has received approval to claim for Motivational Interviewing under Family First as part of the District's comprehensive evidence-based prevention service array, in addition to its use as a substance abuse treatment service.³ Jurisdictions and American Indian/Alaskan Native tribal nations with approved FFPSS plans are depicted in Figure 1 and via the notes below that figure -- which was designed by Don Winstead using information from the ACF/CB website as of December 22, 2022.

Interventions that States Plan to Include in Their FFPSA Prevention Plan

In Table 3 we identify the interventions that states, AI/AN Tribal Nations, Washington, D.C., and the U.S. Territories have included in their FFPSA plan or have had approved by the Federal Government. In this edition of the summary, we include about eight American Indian/Alaskan Native-focused interventions that were included in the Alaska FFPSA state plan, which was submitted to the U.S. Children's Bureau but then withdrawn. Note that Family Spirit was recently rated as Promising by the Prevention Clearinghouse.

The interventions selected by 15 or more states, Tribal Nations, U.S. Territories and Washington, D.C. are listed below:

- Functional Family Therapy (34 jurisdictions)
- Healthy Families America (25 jurisdictions)
- Homebuilders (16 jurisdictions)
- Motivational Interviewing (29 jurisdictions)
- Multi-Systemic Therapy (also related to Intercept in 5 jurisdictions) (28 jurisdictions
- Nurse Family Partnership (20 jurisdictions)
- Parent Child Interaction Therapy (26 jurisdictions)
- Parents as Teachers (28 jurisdictions)
- Trauma-Focused Cognitive Behavioral Therapy (17 jurisdictions)

It was important to see that some jurisdictions have selected Clearinghouse-rated interventions that were created for specific children and families of color:

- Effective Black Parenting Program (EBPP)
- Familias Unidas
- Family Spirit

The number of interventions with evidence that they are effective with children and families of color and *LGBTQ2SI*+ persons is increasing but many more evaluation studies need to be completed.⁶

⁷ California will select all EBPs with a Well-Supported rating, as currently approved by the Title IV-E Prevention Services Clearinghouse for inclusion at the inception of the Title IV-E Prevention Program. As they become available, any new Well-Supported services that have been included in the Title IV-E Prevention Services Clearinghouse may be integrated into the selected automation solution and a state plan amendment will be submitted to make them available for use by local IV-E Agencies. California intends to use Motivational Interviewing as a cross-cutting intervention beyond solely substance use disorder treatment, showing considerable success in services including in-home parenting skill-building, mental health treatment, and family engagement and interaction.

¹⁵ The Eastern Band of Cherokee included this approach in their FFPSA plan. "This intervention has been a means of healing for thousands of years, when there was an understanding that one's cultural identity and sense of belonging within the community was a core facet to wholeness and healing in an individual and in a family system. Due to historical trauma, many families were forced to abandon facets of their culture, and this separation from cultural identity is often credited as a major factor in many present challenges, particularly the opiate crisis within American Indian populations. Reengaging struggling families within their culture is not a new idea but utilizing this engagement as a protective factor for families on the brink of their children entering care will be. The Family Safety Program will locate experts in Cherokee Language and cultural practices (such a basket weavers, story tellers, medicine makers) based on their respect within the community as such and participation in appropriate traditional means of training, and connect them to families to work with children or parents to engage them in cultural practices and work with them on reintegrating their identity as a Native person and the healing which this will bring." Table Notes

Some states are in the process of determining which interventions will be included in their plan. Note that not all the jurisdictions in Table 3 have formally submitted their FFPSA plans to the Federal government or made them available publicly, so some of those states have not been included in the table to accommodate the American Indian/Alaskan Native tribal nations and Puerto Rico.

We do not yet have a document design that will accommodate all the states, American Indian Tribal Nations, and U.S. Territories when their FFPSA plans are drafted or approved. Thus, the table does not yet have columns for Alabama, Arizona, Guam, Idaho, Mississippi, Pennsylvania, and U.S. Virgin Islands. When we do have intervention information for these jurisdictions, we will either add them to the table or list their interventions in this section.

State Intervention Planning Notes

- Arkansas: Most of these EBPs will be implemented in phases.
- Hawaii: State leaders will review whatever services are submitted through Clearinghouse current "Call for Services" and will further use those as guideline on how to proceed with Services assessment.
- Kansas: Kansas has developed their own approach to Family Preservation Services, and this intervention has been accessed extensively as a prevention program for families. It will remain an option for home-based, intensive, therapeutic and/or case management services offered to families in crisis when children are at high risk of outof-home placement.
- Kentucky: Interventions listed are from their submitted FFPSA plan. •
- Nebraska Additional Interventions: Nebraska did a Request for Qualifications (RFQ) and these are the providers' proposed models that scored sufficiently. This is subject to change based on outcomes of the Gaps/Needs Analysis being conducted by Chapin Hall. The Nebraska RFQ is still open for providers to apply to at this time. Nebraska is working towards setting rates for the 9 services and will share that information with the provider community once reviewed, approved, and finalized by executive leadership.

- New Jersey: In the table are the interventions already being provided and those that have been provided prior to FFPSA. Due to Medicaid-related FFPSA guidance released recently, the state is in the process of considering additional models.
- Ohio: Ohio is planning to use three implementation phases, with additional interventions implemented in phases 2 and 3. All the interventions, however, are included in Table 3. •
- Oregon: Oregon has also identified several EBPs of interest for future phases of implementation: Community Healing Initiative (CHI), FAIR (Families Actively Improving Relationships), Healthy Families American (HFA)/Healthy Families Oregon (HFO), Make Parenting a Pleasure (adapted), Nurse-Family Partnership (NFP), Parents Anonymous, Parent Management Training Oregon (PMTO), Self Enhancement Model (SEM), Sobriety Treatment and Recovery Teams (START), Trauma-Focused Cognitive Behavioral Therapy (TF-CBT), Youth Villages - Intercept. They also plan to implement some Tribal Best Practices: Adventure Based Practices, Canoe Journey - Family, Ceremonies and Rituals, Cradle Boards, Cultural Camp, Domestic Violence Group Treatment for Men, Family Spirit, Family Unity, Healthy Relationship Curriculum, Horse Program, Native American Community Mobilization, Native American

Storytelling, Positive Indian Parenting, Powwow, Round Dance, Sweat Lodge, Talking Circle, Trauma Recovery and Empowerment Model (TREM), Tribal Crafts, Tribal Family Activities, Tribal Youth Conference. (See pp. 22-25 in the Oregon plan.)

- Utah: Services that are currently being considered for future amendments (which will be reviewed by the University of Utah) include ACT, DBT (for youth and for adults), Helping Men Recover, and Helping Women Recover. Utah is also considering Multi-Systemic Treatment as an intervention as well as Wraparound or High-Fidelity Wraparound.
- Washington DC: The District of Columbia (Washington DC) also included in its plan the following interventions that need further evaluation but that they see as effective for their families: Mobile Stabilization Services (MSS), Certified Peer Specialists, Family Peer Coaches - Strengthening Family Coping Resources (SFCR),⁴⁴ C.A.S.E. - Center for Adoption Support and Education, Adoptions Together, and The Association for Successful Parenting (TASP): Successful Parenting DC.⁴⁵
- Washington State: State leaders also have plans to undertake additional Evidentiary Review (as specified in the Transitional Payment PI) and submit an expanded list in the future. They chose their initial list primarily based on EBPs that they already have contracts for, and have some level of supportive infrastructure in place, in addition to the EBP having been reviewed or under review by the Clearinghouse.

Interventions Especially Appropriate for American Indian/Alaskan Native Families

Tribes who are approved for direct Title IV-E funding from the federal government are not bound by the Evidence-Based Program requirement but can qualify programs for Family First funding under separate tribal criteria using community and practice-based evidence. It is likely that several programs included in the Oregon and Alaska plans would meet these criteria. Tribes that access Title IV-E through a tribal-state agreement, however, can currently receive Family First funding only for approved Evidence Based Programs, although guidance summarized in ACYF-CB-IM-21-04 indicates that some cultural adaptations to EBPs are permissible. None of the activities and programs listed in this chart have been approved as interventions as of this time. Of course, both states and tribes can support these programs and include them as part of a comprehensive prevention strategy regardless of whether they qualify for Family First funding.
